



RTHETAPHI SOFTWARE LICENSE AGREEMENT

Software Product: Waveguide Sample Analyzer

Version: 1.0

Effective Date: August 2026

Please read this Software License Agreement ("Agreement") carefully before installing or using this software.

By installing, copying, activating, or using the software, you agree to be bound by the terms of this Agreement.

1. Definitions

For purposes of this Agreement:

"Software" means the Rthetaphi software product identified above, including executable files, software components, documentation, graphics, and related materials provided by Rthetaphi.

"Trial Edition" means the edition of the Software provided without charge for evaluation purposes and subject to the trial limitations specified by Rthetaphi.

"Licensed Edition" means the fully activated edition of the Software made available after a valid license has been purchased and successfully activated.

"License Key" means the license credential issued by Rthetaphi for activation of the Licensed Edition.

"Rthetaphi" means Rthetaphi, the owner and licensor of the Software.



2. Trial License

The Trial Edition is provided free of charge for evaluation purposes and is subject to the functionality limitations specified by Rthetaphi.

The Trial Edition does not require purchase or activation of a paid license for its evaluation functionality.

The Trial Edition may continue to be used for evaluation subject to the functionality limitations of the Trial Edition and the terms of this Agreement.

The Trial Edition does not grant the user the rights or functionality provided by the Licensed Edition.

3. Purchase and Licensed Use

Upon purchase of a valid license from Rthetaphi, you may activate the Software installed on your computer using the License Key or other activation credentials provided by Rthetaphi.

Upon successful activation, the same installed Software may transition from the Trial Edition to the Licensed Edition. A separate installation is not required. The Licensed Edition becomes active after the Software automatically restarts.

The Licensed Edition grants you a perpetual, non-exclusive license to use the Software, subject to the terms of this Agreement.

The license permits use of one activated copy of the Software on one computer at a time. An activated license may be associated with the computer on which it is activated. The authorized license holder may move the license from one computer to another by activating the license on the other computer. The license may not be used simultaneously on multiple computers.

A purchased license may be permanently transferred or gifted to another person, subject to Section 8 of this Agreement. Upon completion of such a transfer, the original



license holder must cease using the transferred license, and the recipient becomes the authorized license holder.

4. License Activation and Verification

New activation of the Licensed Edition requires an Internet connection.

Rthetaphi may use an online activation and license-verification system to verify and manage the authorized use of a license.

Rthetaphi may use reasonable technical measures to authenticate licenses, protect the Software, and prevent unauthorized use.

5. Ownership and Intellectual Property

The Software, including but not limited to its source code, executable files, algorithms, methods, designs, documentation, graphics, user interface, and related materials, is the intellectual property of Rthetaphi and is protected by copyright and other applicable intellectual-property laws.

This Agreement grants you a limited license to use the Software. It does not transfer ownership of the Software or any intellectual-property rights to you.

All rights not expressly granted under this Agreement are reserved by Rthetaphi.

6. Restrictions

Except as expressly permitted by this Agreement or applicable law, you may not:



- Copy, reproduce, distribute, publish, sublicense, rent, lease, sell, or otherwise distribute or commercially provide the Software or any portion of it, except as expressly authorized by Rthetaphi.
- Provide the Software or a License Key to another person for simultaneous or unauthorized use.
- Share, publish, resell, or otherwise distribute a License Key or activation credentials except as part of an authorized license transfer or gift permitted by this Agreement.
- Use a transferred or gifted license after the license has been transferred to another person.
- Reverse engineer, decompile, disassemble, modify, or attempt to discover the source code of the Software, except to the extent such activity is expressly permitted by applicable law.
- Modify, remove, disable, or bypass any licensing, activation, security, or technical protection mechanism of the Software.
- Attempt to defeat, circumvent, reset, or extend the Trial Edition's trial period or other trial limitations.
- Use a Trial Edition for unauthorized commercial or production use if such use is prohibited by the applicable trial terms.
- Use the Software in violation of applicable laws or regulations.

7. License Key and Activation Credentials

A License Key or other activation credential issued by Rthetaphi is intended for use by the authorized license holder.

A License Key may be transferred to another person only as part of an authorized transfer or gift of the corresponding purchased license.



Except for such an authorized transfer, you may not share, publish, distribute, or make available a License Key or activation credentials to another person for simultaneous or unauthorized use.

The license holder is responsible for maintaining the security of the License Key and activation credentials.

8. License Transfer and Gifting

A purchased license may be permanently transferred or gifted to another person.

The transfer must be for the entire license and may not result in the license being used simultaneously by the original license holder and the recipient.

Upon completion of the transfer, the original license holder must cease using the transferred license.

The recipient becomes the authorized license holder and may activate and use the Software subject to this Agreement.

Activation of the license on another computer automatically replaces the previous computer's activation.

A license may not be transferred or gifted for the purpose of circumventing activation limits or other licensing restrictions.

Rthetaphi may provide reasonable procedures for completing a license transfer.

9. Updates

Rthetaphi may provide software updates, upgrades, bug fixes, patches, or new versions at its discretion.

Unless accompanied by a separate license agreement, updates provided for the Software will be subject to this Agreement.



A perpetual license does not necessarily include every future major version or separately offered product or upgrade.

10. Disclaimer of Warranty

THE SOFTWARE IS PROVIDED "AS IS" AND, TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, WITHOUT WARRANTIES OF ANY KIND, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

RTHETAPHI DOES NOT WARRANT THAT THE SOFTWARE WILL BE ERROR-FREE, UNINTERRUPTED, OR SUITABLE FOR EVERY PARTICULAR APPLICATION.

11. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, RTHETAPHI SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR LOSS OF DATA, LOSS OF PROFITS, LOSS OF BUSINESS, BUSINESS INTERRUPTION, OR OTHER COMMERCIAL DAMAGES ARISING OUT OF OR RELATED TO THE USE OF OR INABILITY TO USE THE SOFTWARE, EVEN IF RTHETAPHI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.



12. Termination

The Trial License remains subject to the functionality limitations applicable to the Trial Edition and may be terminated in accordance with this Agreement.

The Licensed Edition license is perpetual unless terminated in accordance with this Agreement.

Rthetaphi may terminate a license if you materially violate this Agreement and fail to remedy the violation where a remedy is reasonably possible.

13. Changes to the Licensing System

Rthetaphi may modify its activation, license-verification, or licensing infrastructure from time to time for security, maintenance, or operational reasons.

Rthetaphi will not intentionally use such changes to convert a valid perpetual license into a time-limited license.

14. Governing Law

This Agreement shall be governed by the laws applicable to the parties and the transaction, without regard to conflict-of-law principles, except to the extent otherwise required by applicable law.



15. Entire Agreement

This Agreement constitutes the entire agreement between you and Rthetaphi concerning the Software and supersedes prior or contemporaneous agreements concerning the Software, except for any separate written agreement expressly entered into between you and Rthetaphi.

If any provision of this Agreement is determined to be unenforceable, the remaining provisions shall remain in effect to the extent permitted by applicable law.
